#### **Clawson Literacy Coach**

## DISCUSSIONITEMS

#### A. <u>iReady Instruction Licenses</u>

Mrs. McDonald addressed the board. Our 2021 and 2022 Summer School programs were designed to address learning loss and to increase student engagement. Last summer we used the already paid for licenses that students were accessing during the school year. Those licenses are expiring and need to be renewed for this year. The funding source will be the 98c grant which is designed to be used for Learning Loss activities. Purchasing licenses for our students to use during the school day and after school will allow for teachers to have access to a tool that will directly address the areas of need that have been identified by the iReady Diagnostic.

There is a proposal from Curriculum Associates that the board will vote to approve at its November regular meeting.

#### B. Bond Update

Nikki Kerchner and Joe Luther presented the construction timeline, bidding/budget update, including the escalation forecast and building cost index, program budget of 10/17/22, and construction updates.

#### C. <u>Michigan State Funding 98c Public Presentation</u>
