We are pleased to present you with the Annual Education Report (AER) which provides key information on the 2016-2017 educational progress for Clawson High School. We have noticed in increase in the number of students to be considered "at-risk." By definition these students have attendance issues, poor or failing grades and are behind in credits. In order to combat this trend we have added Math Intervention Courses to help students in this category. Additionally, we are continuing to develop our Virtual Learning Lab to help students who are credit deficient grow closer to their goals of graduating from CHS. While these challenges persist we have increased the number of students attending Oakland Schools Technical Campus, Dual Enrollment and the Center for the Advanced Studies and Arts.
